### 1. About Today Markets

Today Markets is a global broker offering Contract for Difference (CFD) trading on a wide range of financial instruments, including forex, indices, commodities, equities, and cryptocurrencies. CFDs are leveraged products and carry a high level of risk.

### 2. Eligibility

To open an account and use our services, you must:

- Be at least 18 years old (or the legal age in your jurisdiction)
- Have full legal capacity
- Not be a resident of any jurisdiction where CFD trading is prohibited

We reserve the right to accept or reject any application at our sole discretion.

### 3. Risk Disclosure

CFDs are complex instruments and come with a high risk of losing money rapidly due to leverage. You should not trade CFDs unless you fully understand the risks and have the financial capacity to bear potential losses. A full **Risk Disclosure Statement** is available on our website and must be reviewed before trading.

### 4. Account Registration and Verification

Clients must complete the account registration process and submit valid KYC documentation as required under our regulatory obligations. This may include proof of identity, proof of address, and financial suitability assessment. We comply with AML (Anti-Money Laundering) and CTF (Counter-Terrorism Financing) laws and may request further information at any time.

### 5. Trading Terms

- **Leverage:** Maximum leverage is subject to regulatory limits and may vary based on account type, instrument, and jurisdiction.
- **Spreads & Commissions:** Fees, spreads, and commission structures are available on our website and may change without notice.

- **Execution Policy:** All orders are executed according to our **Order Execution Policy**, which forms part of this Agreement.
- **Margin Requirements:** You are responsible for maintaining adequate margin. Failure to do so may result in liquidation of open positions.

## 6. Platform Access

We provide access to multiple trading platforms including **MetaTrader 5**, **cTrader**, and **ACT Trader**. Use of these platforms is subject to platform-specific terms. We do not guarantee uninterrupted access and may perform maintenance or suspend services at any time.

---

## 7. Client Funds

Today Markets holds client funds in segregated accounts, separate from company funds, in accordance with regulatory requirements. However, no interest is paid on client funds unless otherwise specified.

---

## 8. Prohibited Activities

Clients agree not to engage in the following:

- Abuse of leverage, platform errors, or latency
- Use of unauthorized automated systems or bots
- Fraudulent activities, including identity theft or money laundering
- Trading strategies that exploit system vulnerabilities or arbitrage

Violation of this section may result in account suspension or termination.

## 9. Withdrawals & Deposits

Deposits and withdrawals must be made through approved payment methods listed on our website. Withdrawals may only be processed to the original funding source. Today Markets reserves the right to request documentation before processing withdrawals.

## 10. Communication and Notifications

All communication will be conducted electronically unless otherwise required. It is your responsibility to ensure your contact details remain up-to-date. Today Markets is not liable for missed communications due to incorrect or outdated information.

## 11. Amendments to This Agreement

Today Markets may amend these Terms and Conditions at any time. Continued use of the services after changes have been posted constitutes acceptance of the revised Agreement.

## **12. Termination**

Either party may terminate this Agreement with written notice. Today Markets reserves the right to suspend or terminate your account immediately in the event of suspected misconduct, fraud, or violation of these Terms.
